**CITY OF NEW HAMPTON, IOWA
 AGRICULTURAL EXEMPTION PERMIT APPLICATION AND APPROVAL**

In the unincorporated area only, no regulation shall apply to land, farm houses, farm buildings, farm outbuildings, and other buildings, structures, or erections which are primarily adapted by reason of nature or area, for use for agricultural purposes, while being so used, provided that the area comprises thirty-five (35) contiguous acres or more which is used for agricultural purposes and the growing and production of all agricultural products. The regulations contained in the Zoning Ordinance, if any, shall, however, relate to and have effect upon any structures, dams, obstructions, deposits, or evacuations in or on the floodplains of any river or stream in the unincorporated area being regulated. A permit, approved by the City shall be required for an exemption.

An applicant who is issued an agricultural exemption permit is bound, by acceptance of the permit, to commence the construction for which the permit is issued and is bound to finish said construction within twelve (12) months from and after said date of issuance. A permit issued under the provisions of the City Zoning Ordinance shall be valid for a period of twelve (12) months from and after the date of issue of said permit. Upon expiration of a permit, the holder shall make a new application for a new permit under the provisions of this chapter and shall otherwise go through the same procedure as required for issuance of the original permit. The fee for the second permit, as in the case of the original permit fee, shall be set by resolution by the City Council.
